a corporation, Grantor (s) and CITY OF TUCSON, a municipal corporation, Grantee hereinafter called the City.

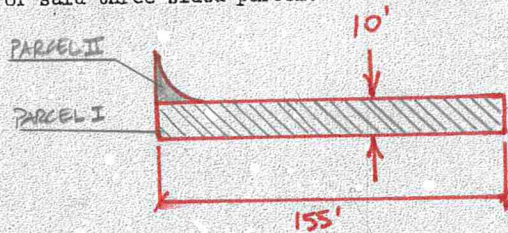
WITNESSETH:

THAT the Grantor, for and in consideration of One (\$1.00) Dollar, and other valuable consideration to it in hand paid by the City, the receipt whereof is hereby acknowledged, does hereby convey unto the City of Tucson, a municipal corporation, its successors and assigns, a perpetual right of way, privilege and easement for the following purpose(s); ~~to be used for municipal services~~ said easment being in, on, through, over, across, and under the following described parcel of land, situate in Pima County, Arizona, to-wit:

Those portions of Lots 3 and 4 in Block 4 of SAWTELLE PLACE, a subdivision of Pima County, Arizona, as per the map recorded in the Office of the Recorder of said County in Book 4 of Maps and Plats at page 73 described as follows:

PARCEL I: The southerly 10 feet of the westerly 155 feet of Block 4.

PARCEL II: A three-sided parcel in Lot 3 bounded on the:
West by westerly line of Lot 3;
South by the northerly line of PARCEL I;
Northeast by the arc of a circle of radius 25 feet,
concave to the northeast, and tangent to the westerly and southerly lines of said three-sided parcel.



TO HAVE AND TO HOLD the same unto the City, and to its successors and assigns forever.
