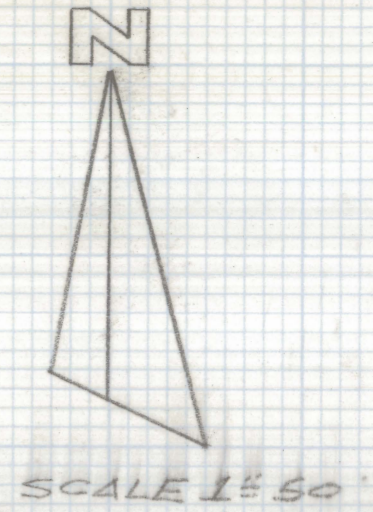
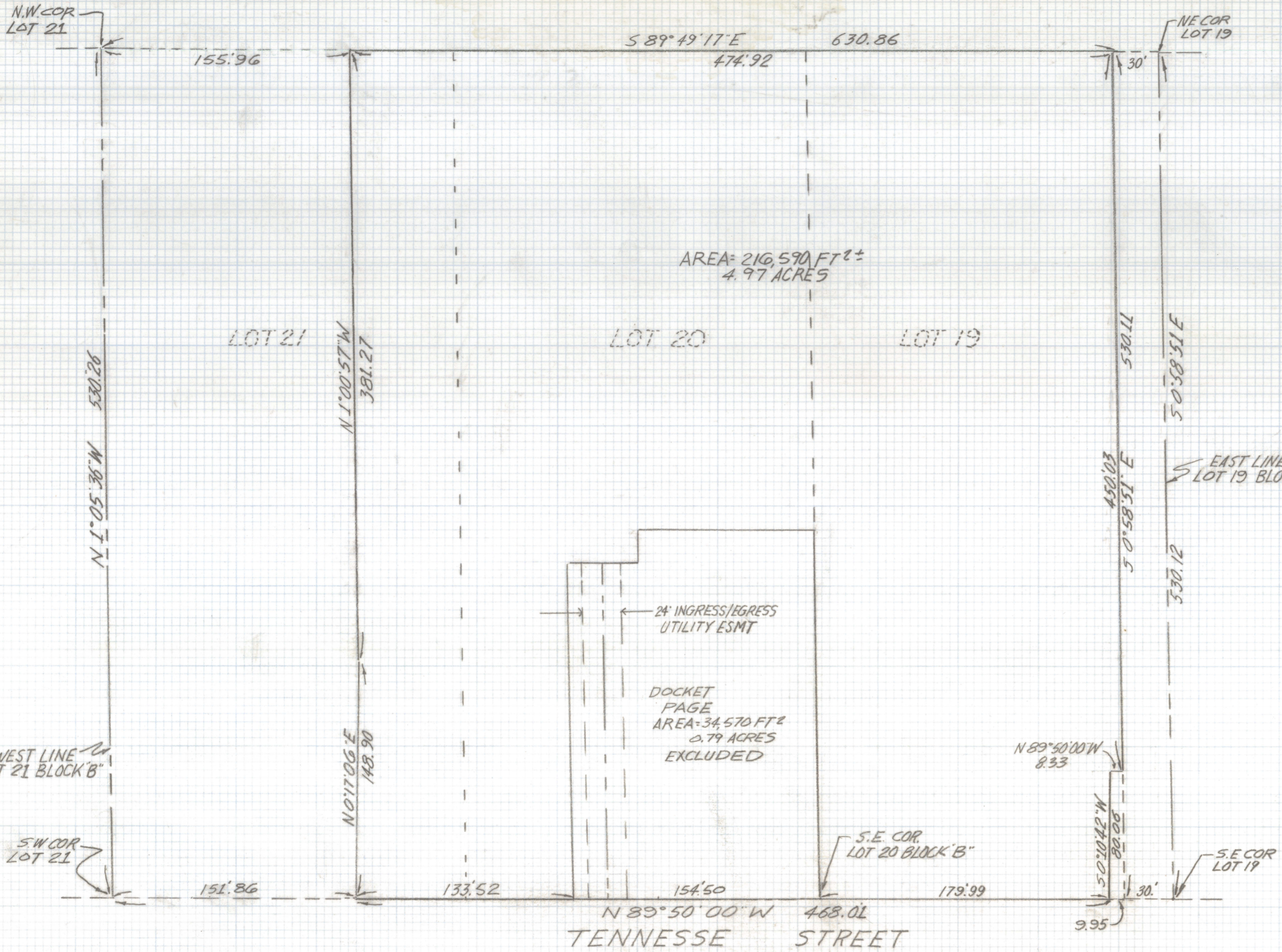


LOCATION MAP

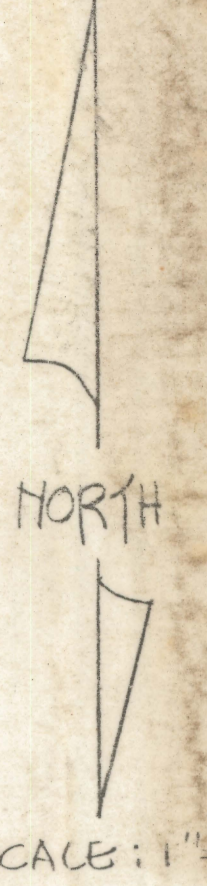
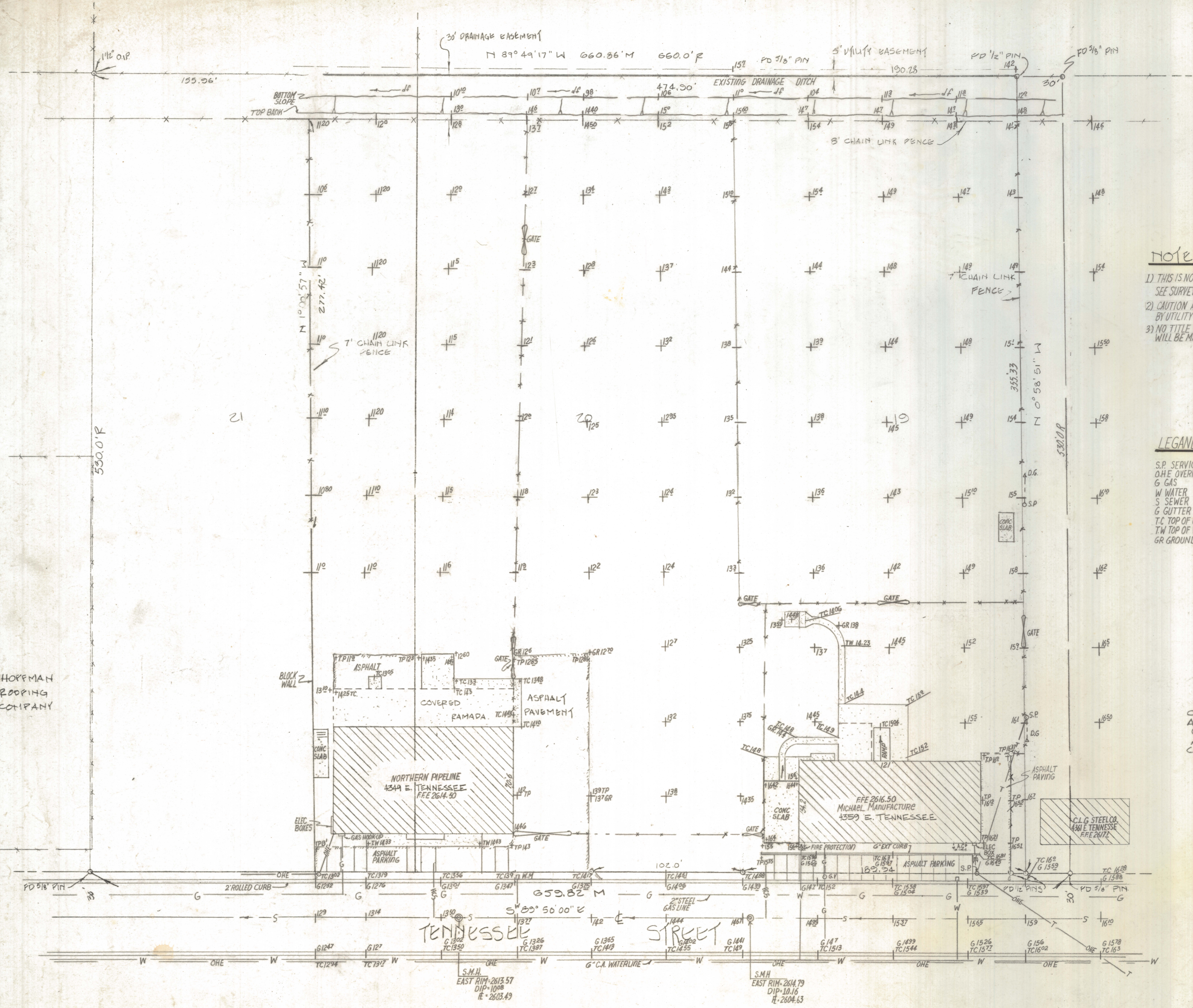

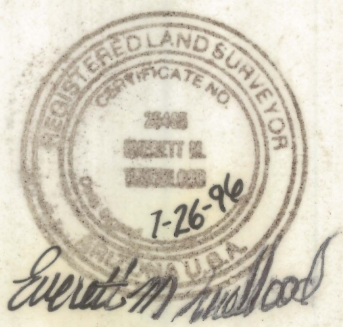
