





LEGAL DESCRIPTION

THAT PORTION OF SECTION 10, TOWNSHIP 14 SOUTH, RANGE 13 EAST, GILA AND SALT RIVER BASE AND MERIDIAN, PIMA COUNTY, ARIZONA, ACCORDING TO THE OFFICIAL SURVEY THEREOF MADE AND EXECUTED BY T.F. WHITE UNDER THE PROVISION OF THE ACT OF CONGRESS APPROVED FEBRUARY 5, 1875, ENTITLED "AN ACT TO GRANT TITLE TO CERTAIN LANDS IN THE TERRITORY OF ARIZONA" DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT BEING THE INTERSECTION OF THE SOUTHERLY RIGHT-OF-WAY LINE OF ST. MARY'S ROAD AS ESTABLISHED IN BOOK 4 OF ROAD MAPS AT PAGE 77, AND THE EASTERLY RIGHT-OF-WAY LINE OF SILVERBELL ROAD AS ESTABLISHED IN BOOK 4 OF ROAD MAPS AT PAGE 78, RECORDS OF PIMA COUNTY, ARIZONA, SUCH POINT BEING THE TRUE POINT OF BEGINNING; RUN THENCE EASTERLY ALONG THE SOUTHERLY RIGHT-OF-WAY LINE OF ST. MARY'S ROAD ON A BEARING OF NORTH 84° 17' 58" EAST, A DISTANCE OF 128.63 FEET TO A POINT IN THE WESTERLY LINE OF THAT CERTAIN PARCEL OF LAND DESCRIBED IN DEED TO ROBERT B. BARRETT AND EUGENTA R. BARRETT, HUSBAND AND WIFE, AND RECORDED IN SAID PIMA COUNTY RECORDER'S OFFICE IN DOCKETT 336 AT PAGE 592;


